Under section 2(ca) of the Factories Act, 1948 read with Rule 2-A of the Punjab Factory Rules, 1952, for the purposes of carrying out tests, examinations and certification of buildings, hoists and lifts, lifting machines and lifting tackles, pressure plants, dust extraction systems etc.
