G.S.R.42 .-In exercise of the powers conferred by sub-section (1) and (2) of section 101 of the Rights of Persons with Disabilities Act, 2016 (Central Act No.49 of 2016), the State Government proposes to make the following rules further to amend the Rajasthan Rights of Persons with Disabilities Rules, 2018. The following draft rules are hereby published for the information of the persons likely to be affected thereby and notice is hereby given to them that the said draft rules shall be taken into consideration after the expiry of a period of seven days from the date on which the copies of this notification as published in the Official Gazette are made available to the public;

Any objection or suggestion which may be received from any person with respect to the said draft rules before the expiry of the period specified above will be considered by the State Government. Such objection or suggestion should be addressed to the Director, Special Aabled Persons, G-3/1-A, VisheshYogyajanBhawan, Behind Rajmahal Hotel, Jaipur (Rajasthan) or by email at dir.dsap@rajasthan.gov.in.

DRAFT RULES

1. Short title and commencement.-(1) These rules may be called the Rajasthan Rights of Persons with Disabilities (Draft Amendment) Rules, 2025.

(2) They shall come into force from the date of their final publication in the Official Gazette.

2. Amendment of rule 5.- The existing second proviso to sub-rule (1) of rule 5 of the Rajasthan Rights of Persons with Disabilities Rules, 2018 shall be substituted by the following, namely:-

"Provided further that the reservation in promotion, with effect from 30.06.2016, shall be in accordance with such instructions as may be issued by the State Government, from time to time. The person, who had been promoted before commencement of the Rajasthan Rights of Persons with Disabilities (Amendment) Rules, 2025, shall not be reverted due to promotion of person with disability from earlier year. In case where number of persons promoted becomes

more than the number of sanctioned posts, the administrative department may create shadow post with the concurrence of the Finance Department."
