CIRCULAR

It has come to the notice that a fraudulent Minimum Wage Dearness Allowance revision order F.No.(143)/02/MW/VII/Partfile/212-261 dated 13.10.2025 is being circulated. The forged order falsely attributes the signature to Sh. K.M. Singh, Jt. Labour Commissioner.

It is to bring to the knowledge of all concerned that the Labour Department, Government of National Capital Territory of Delhi (GNCTD), has not yet issued any order regarding Dearness Allowance in Minimum Wages for the period starting October 1, 2025.

The public and all stakeholders are advised to ignore this fake order and to refrain from circulating and enforcing it.

For the most accurate and up-to-date information on minimum wage rates, always refer to the official website of the Labour Department, GNCTD. The last official increase in minimum wages for Delhi was effective from April 1, 2025.

ORDER

Whereas the Government of National Capital Territory of Delhi had last revised the minimum rates of wages in Schedule Employments under the Minimum Wages, Act, 1948 vide notification no. 12(142)/02/MW/3637 dated 22/10/2019.

And whereas in the above mentioned notification it was stipulated that the Dearness Allowances will be payable on the basis of six monthly average index numbers of January to June and July to December on 1st April and 1st October respectively.

And whereas, the Government of National Capital Territory of Delhi after adjustment of the average All India Consumer Price Index Number of the Period from July to December, 2025, which is 413.42, an increase of 11.32 points, hereby declares the following Dearness Allowances, which shall be payable for all categories w.e.f. 01.10.2025.

The following revised rates of minimum wages shall be applicable in respect of unskilled, semiskilled and skilled categories in all schedule employments:-
