**No. 535694-HII(2)-2026/3143.**—In exercise of the powers conferred by Section 28 of the Punjab Shops and Commercial Establishment Act, 1958 (Punjab Act No. 15 of 1958) (hereinafter referred to as 'above said Act'), as applicable to the Union Territory of Chandigarh, and all other powers enabling him in this behalf, the Administrator, Union Territory of Chandigarh is pleased to direct that from the date of issuance of this notification, all the establishments which falls within the definition of 'establishment' and are otherwise covered under the above said Act and are also required to be and are registered under the Occupational Safety, Health and Working conditions code, 2020 and the rule framed thereunder, shall be exempted from complying with the provisions of section 13 or under section 13A of the above said Act and the rules framed thereunder in order to avoid duplicacy of registration process and to simplify the procedural compliances.

**Notification**

The 18<sup>th</sup> March, 2026

**No. 535694-HII(2)-2026/3140.**—Whereas, the Administrator, Union Territory, Chandigarh, in exercise of the powers conferred by Section 28 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act No. 15 of 1958) (herein referred to as ‘Principal Act’) as applicable to the Union Territory of Chandigarh, has issued notification No. 12/2/149-HII(2)-2025/12994 dated 14<sup>th</sup> August, 2025, exempting shops and commercial establishments registered under the said Act from certain provisions thereof, subject to conditions specified therein;

And whereas, the Punjab Shops and Commercial Establishments (Amendment) Act, 2025, has been extended to the Union Territory of Chandigarh by the Government of India, Ministry of Home Affairs, vide notification dated 5<sup>th</sup> December, 2025 wherein several provisions of the Principal Act have been amended;

And whereas, consequent upon the said amendment, it has become necessary to align the conditions of exemption contained in the notification dated 14<sup>th</sup> August, 2025 with the amended provisions of the Principal Act;

Now, therefore, in partial modification of the Notification No. 12/2/149-HII(2)-2025/12994 dated 14<sup>th</sup> August, 2025 (hereinafter referred to as ‘said notification’) and in exercise of the powers conferred by Section 28 of the Punjab Shops and Commercial Establishments Act, 1958, as applicable to the Union Territory of Chandigarh, and all other powers enabling him in this behalf, the Administrator, Union Territory, Chandigarh, is pleased to make the following amendments in the said notification, namely :-

1. For condition No. 6, the following condition shall be substituted namely :-

“6. No employee shall be required to work for more than 10 hours in a day or 48 hours in a week.”

2. For condition No. 13, the following condition shall be substituted, namely :-

“13. The spread over of an employee shall not exceed 12 hours in a day inclusive of interval for rest.”

3. For condition No. 15(i), the following condition shall be substituted, namely :-

“(i) The total number of overtime hours worked by an employee does not exceed one hundred forty-four within a period of [any one quarter]; and”

## HIGH COURT OF PUNJAB AND HARYANA AT CHANDIGARH

**Notification**The 17<sup>th</sup> March, 2026

**No. 61.**—In exercise of the powers conferred under Rule 3-A (vi) of Chapter-6, Part-B, Punjab and Haryana High Court Rules and Orders, Volume V, Hon'ble the Chief Justice has been pleased to include the name of the **258** Advocates mentioned as below, on the Roll of Advocates with effect from date of this notification.

2. The Roll of Advocates is valid for a term of Five Years from the date of this notification or for such term as extended by Hon'ble the Chief Justice. The application for renewal of name on the Roll of Advocates shall be required to be filed alongwith requisite certificate from the Bar Association/Advocates Association, Punjab and Haryana High Court or from the Registrar General of Punjab and Haryana High Court, as and when required.

3. As per Rule 3-A (i) of Chapter 6, Part-B, Punjab and Haryana High Court Rules and Orders, Volume V, unless the Court grants leave, an Advocate who is not on the Roll of Advocates in the Punjab and Haryana High Court, shall not be allowed to appear, act or plead in the Punjab and Haryana High Court as the case might be unless he /she files appointment alongwith an Advocate who is on such roll of Punjab and Haryana High Court.

4. It is mandatory by the Advocate to mention the **Number on Rolls (NoR)** as assigned in Column No. 2 of the list below in all petitions/applications/vakalatnama etc. wherever the signature of an Advocate appear.

5. The request for making correction/change in the particulars on Roll of Advocates can be made to the Registrar General of this Court.

6. Name of an Advocate can be removed, either temporarily or permanently, from the Roll of Advocates on the following grounds:-

- (a) if he/she ceased to practice;
- (b) if he/she is disqualified as an advocate by the Bar Council;
- (c) if he/she is found guilty of mis-conduct of Court or otherwise;
- (d) if he/she is convicted of an offence involving moral turpitude or for contempt of Court;
- (e) if he/she has migrated from India;
- (f) if he/she changes place of practice from the Chandigarh, District Mohali and District Panchkula;
- (g) if he/she has expired;
- (h) on his/her request;
- (i) on any other ground as deemed fit by the Hon'ble the Chief Justice or any other competent authority to be appointed by the Hon'ble Chief Justice of High Court of Punjab and Haryana for this purpose.
