In pursuance of the Government instructions issued in the reference 1st read above and in the circumstances reported by the Special Commissioner of Labour, Telangana, Hyderabad in the reference 2nd read above, the following notification shall be published in the extra-ordinary issue of Gazette Notification of Telangana State:

NOTIFICATION

In exercise of the powers conferred under Section 3(2) of the Telangana Factories and Establishments (National, Festival and Other Holidays) Act, 1974 (Act No.32/1974) read with the provisions laid down in Section 135-B of the Representation of Peoples Act, 1951, Government of Telangana hereby declare paid holiday to all the employees / workers in the Factories and all Shops & Establishments as defined u/s 2(d) and 2(e) of the said Act, who are employed in Telangana in any business, trade, industrial undertaking or any other establishment and shops including those who work on shift basis / daily wage / casual workers who are electors of either Assam, Kerala, Tamil Nadu, West Bengal or Puducherry and presently residing in the State of Telangana, on the respective dates of poll as fixed by the Election Commission of India, vide. Lr.No.78 / EPS /2026, Dt:16-03-2026, so as to enable the electorate to exercise their vote on the dates of polling in the States of Assam, Kerala and UT of Puducherry [Poll on 09.04.2026 (Thursday)] ; Tamil Nadu:[Poll on 23.04.2026 (Thursday)] and West Bengal [Poll on 23.04.2026 (Thursday) & on 29.04.2026 (Wednesday)], if there is no Holiday.

2. The Commissioner of Labour, Hyderabad and the Director of Factories, Hyderabad shall take further necessary action, accordingly.
